Frequently Asked Questions

1. Obtaining the EU-CONEXUS certificate

A- To obtain the EU-CONEXUS certificate you need to validate (with a minimum of 10/20) all 5 courses worth 6 ECTS credits each.

B- These courses must be chosen from at least two different sectors (highlighted in the course catalog) and from at least 3 universities (La Rochelle is authorized).

C- For each course, you'll have to sign the Learning Agreement contractualizing your courses with our partners.

D- Please note! You can validate your licence without obtaining the certificate: For example: you obtain a 9/20 on an EU-CONEXUS course in semester 3 but you validate your semester by compensation (average $\geq 10/20$).

2. Exchange semester

If you are planning to spend a semester abroad during your degree course:

You need to plan ahead if you want to obtain the EU-CONEXUS certificate, as you must take all 5 courses in the minor.

If you wish, you can take a second EU-CONEXUS course during a semester (before or after the exchange semester) to validate the certificate.

During your exchange semester (if you haven't planned ahead), you'll have several choices:

A- Take courses in the exchange country for 24 credits + 6 of the EU-CONEXUS course.

B- Take courses in the exchange country for 30 credits + 6 of the EU-CONEXUS course (to obtain the certificate)

C- Take courses in the exchange country for 30 credits and do not take any EU-CONEXUS courses, but you will not obtain the EU-CONEXUS certificate at the end of L3.

3. L3 internship and EU-CONEXUS courses

L3 internships generally take place from mid-April, while EU-CONEXUS courses run from the end of February to the end of May.

You will therefore have to balance your internship with the compulsory synchronous courses (currently 2 per month) and ask your company to allow you to take these compulsory courses.

4. Transcription of grades from partner universities

EU-CONEXUS partners do not use the same grading system as La Rochelle Université.

A grade correspondence table has been validated for all EU-CONEXUS partner universities.

The grade received from the partner is sent to your school's secretariat so that your course's jury can decide on the grade to be awarded, based on the indicative correspondence table below.

5. Catch-up exams for EU-CONEXUS courses

Make-up exams for EU-CONEXUS courses are taken immediately after the Session 1 exams.

A- If the teacher has given you your grade and you have obtained an average, there is no need to take the make-up exam to improve your grade.

B- If you failed the EU-CONEXUS session 1 exam but validated your semester or UE by compensation, we will not take your make-up mark into account, although it will be used (in the case of a mark $\geq 10/20$) to obtain the EU-CONEXUS certificate.

Under La Rochelle University's bachelor's degree regulations, you can no longer improve your grade.
